## Wotton Historic Sporting Trial 2024



### Supplementary Regulations

1. MIDLANDS TRIALS CAR CLUB will organise a Clubmans Historic Sporting Trial on Saturday 9<sup>th</sup> November at Bradley Green, Wotton-Under-Edge, Glos, GL12 7PN
2. The meeting will be held under the General Regulations of Motor Sports UK (incorporating provisions of the international Sporting Code of the FIA) and these Supplementary Regulations.
3. Motorsport UK Permit No(s): TBC
4. The event is open to all fully elected members of the organising club and BTRDA, NPTCC, 750 Motor Club, MCC, HSCC, VSCC, MAC, Stroud and District MC, KBCC, Southsea Motor Club Ltd, Woolbridge MC, Falcon Motor Club, Dellow Register and Golden Valley HLCC
5. All drivers and passengers must produce a valid MSUK competition licence (minimum RS Clubmans) and be a member of a MSUK registered motor club.
6. The event is not a championship round.
7. Scrutineering will start on **09.00** by the signing on tent
8. The event will start at **10.30am** Any competitor not signed on by **10.15** may be excluded.
9. There will be at least 6 sections on private land per day. Details of the sections will be issued at signing on. Public roads will not be used to link sections. The number of rounds will be linked to the weather and the size of the entry. Only intermediate poles provided by the club will be used. The clubs intermediate poles are white with either blue or yellow bands.
10. The entry will be split into groups starting at different hills.
11. Practicing will not be permitted.
12. Number cards issued by the organisers will identify competitors. Starting numbers will be allocated by ballot prior to the event.
13. Pits Area - Not applicable.
14. Judges of Fact - The marshals at the event are judges of fact.
15. Television Coverage - Not applicable.
16. Awards – will be presented as follows, subject to a minimum of four starters in each class. Organisers reserve the right to reallocate awards:

1<sup>st</sup> Overall (Historic Only)  
Best performance by an MTCC member  
1<sup>st</sup> Historic  
2<sup>nd</sup> Historic  
1<sup>st</sup> Post Historic  
2<sup>nd</sup> Post Historic

17. The maximum entry for the meeting is 65 and the minimum is 25. Should any of the above figures not be reached, the organisers have the right to amalgamate classes or cancel the event. Entries will be selected on a first come first served basis.

18. The entry list opens on publication of these regulations and closes finally at midnight on Tuesday (5<sup>th</sup> November) before the event.

All entries must be made via Purple Lap online system.

29. Vehicles must comply with the Motorsport UK Technical Regulations and the Historic Sporting Trial (HST) car formula.

30. Permitted rear tyres for this event

- Historic Class – Blockley 4.50/5.00x18

- Post Historic Class – Any Tyres as per 14.8.2 in Motorsport UK Year Books

31. A minimum tyre pressure will be applied on the day at the discretion of the Clerk of the Course. Checks may be carried out to confirm compliance. A maximum of 12 penalty points can be applied for each breach of the rule.

32. No person may drive, or be a passenger in, a competing car on the site unless they are the official crew for that car. The Clerk of the Course is responsible for the safe running of the trial. No marshal or competitor may change a section without the express permission of the Clerk of the Course.
